## **Super Lawn Truck 2 Week Test Drive Agreement**

This agreement administered by Super Lawn Truck, Inc. governs the test drive of our Solar Lawn Truck for the temporary use of PRE-APPROVED lawn and landscape maintenance companies.

Vehicles available in this agreement are limited to those vehicles which GVWR (Gross Vehicle Weight Rating) **does not require** a Commercial Driver's License, **but does require the operator to have:** 1) State issued driver's license, 2) DOT Health Card and 3) Proof of commercial vehicle and liability insurance.

The terms and conditions of this two-week test drive are listed below:

1. This is a 2-week, temporary rental agreement.
2. The 2-week fee is **\$2000.00**.
3. The deposit amount is **\$500.00**.
4. The deposit is refundable based on the condition of the vehicle upon return.
5. The mileage restrictions are **1500 miles** per 2-week test drive period.
6. There is a **\$0.50** per mile overage fee.
7. Super Lawn Truck, Inc. must be listed on your insurance policy as an additional insured and a proof of insurance certificate **ACCORD FORM** must be active prior to delivery of the truck.
8. The lessor may purchase this vehicle at the end of the rental term for the amount of **\$\_\_80,819.00\_\_** plus sales tax and applicable fees. We will apply a \$1000 credit if purchase is made at the end of your test drive.
9. The vehicle must be returned to our location during normal business hours, M-F 8 am to 5 pm EDT, excluding national holidays.
10. Only listed drivers may operate this vehicle during the rental period.
11. No modifications to this vehicle are allowed during the rental period.
12. The renter must maintain liability insurance as the operator for the duration of the rental agreement.
13. Renter is responsible for any damages incurred while operating the vehicle.
14. The renter will be required to provide a copy of a police report if the vehicle is damaged in an accident.
15. If the vehicle requires repairs due to any mechanical failure, the renter will notify the rental company so the repairs can be completed.
16. Renter understands that **gas** powered trucks require **87 octane** fuel only and must be returned with a full tank of fuel or you will be charged for fuel at \$4/gal. \_\_\_\_\_
